

Request to WHO

concerning the role of integrative medicine in the 'pandemic'.

After unsuccessful inquiry to the WHO Department of Traditional, Complementary and Integrative Medicine (TRM) regarding their autonomy especially during the 'pandemic' and regarding the 'vaccination' recommendation, I addressed the following letter to *Tido von Schoen-Angerer, MD, Vice-President, International Federation of Anthroposophic Medical Societies* and *Consultant in the WHO Department of Traditional, Complementary and Integrative Medicine:*

"I have sent to the WHO Department of Traditional, Complementary and Integrative Medicine below attached* question. First on April 26, 2023 and then again on June 22, 2023 - each time without receiving a response.

The issue is why WHO has not recommended autonomous alternative medical treatment at Covid, i.e., omitting the recommended vaccination practice.

Now I have a question for you if it is possible for you to raise this question in that Department and obtain an answer."

"Can you please tell me why the "Traditional, Complementary and Integrative Medicine" has played no role in the response to the Corona pandemic. WHO houses these branches of medicine in a special department, but has not given them space to operate alternatively (alongside vaccination practices). - Why is this the case?"

¹ I put 'pandemic' in apostrophes because the pandemic definition has been systematically softened by the WHO and is just as applicable to an ordinary, harmless wave of influenza as it is to a massively deadly wave of disease. ² I put 'vaccination'-practice in apostrophes, because it is not a vaccination in the linguistic usage up to the C-pandemic, but a novel, therefore extremely inexperienced and

not finished tested, genetic engineering procedure with therefore a huge potential of unknowns. The term 'vaccination' is therefore extremely misleading to the public.
